Sunview Solariums® warrants that components of this product (listed below) to be free of defects in manufacturing which affect the function of the unit under normal use for the periods specified below:

- (1) Sunview Solariums® Acrylic sheets have a limited ten (10) year warranty directly from the manufacturer.
- (2) Sunview Solariums® aluminum frames, frame components, gaskets and screws are warranted against defects in workmanship and material for five (5) years from the date of Installation, providing the installation is in accordance with the manufacturer's instructions, Sunview Solariums®, in its' sole judgment will repair, replace or make a refund for a defective unit, up to the value of the product when first sold by Sunview Solariums®
- (3) Sunview Solariums® accessories: doors, windows, vents, fans, thermostats are guaranteed to be free of manufacturers' defects for a period of one (1) year from date of installation.

## EXCLUSIONS AND LIMITATIONS

The warranties on aluminum components, hardware, glazing, and accessories are exclusive to the manufacturer of same, and Sunview Solariums® makes no other warranty of any kind whatsoever, except for repair, replacement or refund when defective goods are returned to the factory at the purchaser's expense. Sunview Solariums® shall not be liable under any circumstances for removal or dismantling of an installed product, nor for crating, shipping, reinstallation, nor for any incidental or consequential damages. Sunview Solariums® total liability under this warranty is limited to the amount originally paid to Sunview Solariums® for the product, and Sunview Solariums® reserves the right to refund said amount in lieu of repair or replacement. Sunview Solariums® reserves the right to product modifications or substitutions without notice and shall not be liable as a result of discontinuance or changes. Colour variance of replacement parts, due to manufacturing or normal weathering shall not be considered to be a defect. This warranty is personal to Sunview Solariums® and continues under the terms described herein only so long as Sunview Solariums® continues to supply the product. No person is authorized to alter Sunview Solariums® warranty without proper written consent in writing from the Head Office. This warranty does not apply in the event of improper handling or installation, misuse or abuse, accident, neglect, acts of God, fire, flood, hail or incidental damages.

This warranty shall be valid only after the registration certificate attached to this warranty is completed by an authorized dealer, signed by the original purchaser, and returned to Sunview Solariums® within fifteen (15) days after receipt of the product. Return of the registration certificate is a condition precedent to coverage of under this warranty.
